Approval of Minutes from January 19, 2016 Meeting

Health Alliance Medical Plan Update and Review

Ms. Busey announced that Gallagher has been engaged for another 5 year agreement for services; as a result of the bid process we went through. Mr. Malachowski shared a handout comparing physician charges from 2013 – 2015. This was a request from Ms. Berkson at the last meeting. Mr.

Malachowksi explained that E & M stands for Evaluation and Management. He also noted that HCPSC is a Health Care Common Procedure Coding System. This category covers equipment use and some types of therapies. The committee discussed options to educate County employees; to help them to be better health care consumers and keep costs low. He reminded the group that eight of the top (most expensive claims) nine claims in 2015 were related to cancer.
