Overall, the majority of people who answered the survey are happy with the plan and choice.

Malachowski provided a detailed review of claims paid through the end of April 2019. Due to confidentiality, documentation was not provided to the group. It was mentioned that the demographics have not changed drastically however there was a small uptick in claims by \$200,000 in the first four months of 2019.

III. Health Insurance Survey Results

Malachowski reviewed the renewal rate from BCBS. The renewal rate summary for January 1, 2020 quotes medical coverage with BCBSIL at a +4.5% increase (2.4% + 2.1% ACA). The Dental Plans, Life (Basic and Voluntary), Vision, Cancer and Accident Plans do not have any rate changes for the year 2020. BPC has not provided any information at this time, however Malachowski stated that, if there is an increase, it would be minimal. The proposal was not sent to other providers. Malachowski said that Health Alliance would not provide a competitive offer and Ogden stated that there is no value going through the bidding process with Health Alliance.
