#### III. Health Insurance Plan Renewal Quote

Mr. Malachowski reviewed the Renewal Rate Summary for January 1, 2020 handout. He noted that the medical coverage with BCBSIL has a +4.5% increase (2.4% + 2.1% ACA). The Dental Plans, Life (Basic and Voluntary), Vision, Cancer and Accident Plans do not have any rate changes for the year 2020. BPC has increased the Flex Plan by .10 cents or from \$3.90 to \$4.00 per employee.

Ms. Lusk requested a caucus for the labor union members prior to a vote.
