WHEREAS, Pursuant to 10 ILCS 5/25-11, when a vacancy occurs, in any elective county office, the county board shall declare that such vacancy exists and notification thereof shall be given to the county central committee of each established political party, and the vacancy shall be filled within 60 days with the advice and consent of the County Board; and

WHEREAS, the Champaign County Republican Central Committee recommends the appointment of Stephen Thuney to fill the unexpired term, in the Office of County Coroner, ending on November 30, 2024; and

NOW, THEREFORE BE IT RESOLVED By the County Board of Champaign County that Stephen Thuney is appointed to fill the unexpired term, ending November 30, 2024, in the Office of the County Coroner of Champaign County, Illinois.

WHEREAS, during his tenure as a Champaign County Board Member Kyle Patterson also served in a leadership role as the Chair of the Justice & Social Services Committee from 2018-2020; the Chair of the Public Aid Appeals Committee from 2021-2023; and the Chair of the County Board from 2020-2024; and

WHEREAS, the Champaign County Board seeks to publicly recognize the commitment and dedication of Kyle Patterson who served the citizens of Champaign County as an elected official over a term of seven years;

NOW, THEREFORE, BE IT RESOLVED that the Champaign County Board hereby recognizes the service of Kyle Patterson and the benefit that service brought to county government; and
