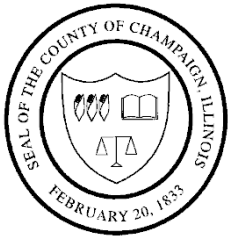

I. Call to Order

Chair Summers called the meeting to order at 1:07 p.m.

II. Roll Call

A verbal roll call was taken, and a quorum was declared present.

III. Approval of Agenda/Addendum

MOTION by Ms. Chynoweth to approve the agenda; seconded by Mr. Davis. Upon vote, the **MOTION CARRIED** unanimously.

IV. Approval of Minutes

MOTION by Ms. Chynoweth to approve the minutes of December 12, 2023; seconded by Mr. Davis. Upon vote, the **MOTION CARRIED** unanimously.

48 **A. Oath, Testimony, & Receipt of Evidence from Appellant**

50 Chair Summers swore in the appellant. The appellant provided additional evidence as
51 requested at the previous meeting. He stated the evidence makes it clear that the Township did
52 not clarify what additional information they required. Once they gave him a list, he was able
53 to provide that information immediately.

54
55 Ms. Chynoweth confirmed that the appellant is currently receiving general assistance. She
56 noted that a list of the additional information required was sent to his case manager at
57 Rosecrance, since they did not have an address on file and she asked if he received that from
58 Rosecrance. The appellant stated he has had many issues with Rosecrance, and he can't recall
59 what or when he received anything from them. Ms. Chynoweth also confirmed that the
60 appellant believed the Township would email him with their response.

62 **B. Oath, Testimony, & Receipt of Evidence from Township**

63
64 Chair Summers swore in Ms. Blair. Ms. Blaire provided a copy of the application that was
65 received from the appellant. She mentioned the list of required information that is posted
66 online with the application and the item that says additional documentation may be requested.
67 She also stated there wasn't a phone number or mailing address for the Township to discuss
68 the application with the appellant.

69
70 Mr. Davis asked how they were able to contact the appellant. Ms. Blair stated she took the
71 denial letter to Rosecrance. Ms. Chynoweth asked if the Township sent the denial letter to the
72 email that was provided in the application. Ms. Blair admitted that she did not realize there
73 was an email in the application and explained that when they receive an incomplete
74 application, they hold it until the applicant contacts them.

75
76 Mr. Davis clarified the timeline, and Ms. Blair detailed the heated phone call that she received
77 from the applicant on February 10th.

78
79 The appellant requested a moment to rebuttal and explained that he submitted the application
80 on January 3rd to the best of his ability and provided contact information. He also stated that
81 the Township did not contact Rosecrance until after the phone conversation.

83 **C. Closed Session Pursuant to 5 ILCS 120/2(c)(4) to Consider Evidence or Testimony**
84 **Presented in Open Hearing to This Quasi – Adjudicative Body**

86 MOTION by Mr. Davis to enter CLOSED session pursuant to 5 ILCS 120/2(c)(4) to consider
87 evidence or testimony presented in open hearing to this quasi-adjudicative body and that the
88 following parties remain present: recording secretary; seconded by Ms. Chynoweth. Upon roll
89 call vote, the MOTION CARRIED unanimously.

91 The Public Aid Appeals Committee entered Closed Session at 1:29 p.m.

D. Announcement of Decision

After consideration of the testimony and evidence presented by the township and the appellant, the Committee ruled in favor of the appellant, awarding them two months of back pay.
