- Attended IEMA-OHS Recovery/Resiliency Monthly Learning Sessions: Fire Safety Practices in the Workplace – Dec 19th




Information Dissemination to Champaign County

CCEMA had **69,777 views** of its social media content and gained an additional **245 new followers**.


