handler, conducted a routine traffic stop in the village of Savoy. During the traffic stop, the deputy utilized a state certified narcotics detection canine, to screen the exterior of the vehicle involved for the presence of illegal drug odor (s). During the traffic stop, a probable cause search of the violator vehicle was conducted, after the canine alerted to the presence of illegal drug odors emanating from inside of the vehicle. While searching the vehicle, a loaded handgun was located in the rear seat of the vehicle and within arms-length of a convicted felon. That handgun was later found to have been stolen during a home invasion, that had occurred in the past and in the city of Champaign. The rear seat passenger was placed under arrest shortly after the firearm was located. However, as deputies attempted to detain the male suspect, he resisted arrest. The male suspect was eventually apprehended and placed in a squad car for transport. He was then transported to the Champaign County Satellite Jail for his offenses.
