Press Release - Crime Activity

Case Synopsis: On March 13th, 2024, a resident of Urbana Township contacted CCSO to report that she had been scammed out of a large sum of money via the internet. The female advised that she had contacted who she believed to be a representative of Microsoft when a popup appeared on her computer warning of a virus and that her computer had been hacked. The fake Microsoft representative was allowed to remotely control her computer and conducted a fake virus scan that showed multiple viruses. The female victim was then instructed to withdraw money from her bank account and purchase bitcoin at a local bitcoin atm, as she was convinced by the scam artist that her bank account had also been hacked. She was told that the bitcoin would encrypt her money and keep it safe. The bitcoin information was provided to the scammers, and they subsequently took possession of the bitcoin.
