26 Kloeppe. Upon vote, the MOTION CARRIED unanimously.

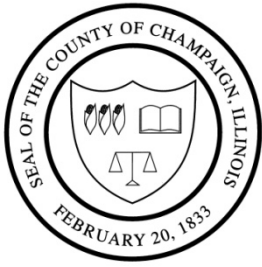
