I. Call to Order

Co-Chair Matthew called the meeting to order at 3:03 p.m.

II. Roll Call

Roll call was taken, and a quorum was declared present.

III. Approval of Minutes– July 22, 2025

MOTION by Mr. McMahon to approve the minutes of July 22, 2025; seconded by Ms. Vanichtheeranont. Upon vote, the **MOTION CARRIED** unanimously.

36 Co-Chair Matthew asked the members if they had any questions. Labor members clarified
37 how terminated employees would be reimbursed and if the County will notify terminated
38 employees.

40 Management requested to caucus at 3:12 p.m.

42 The committee resumed open session at 3:17 p.m.

44 Upon return, Ms. Jett stated the County would reach out to all terminated employees at the
45 contact information provided at termination.

47 **MOTION** by Ms. Lusk to approve the FY25 Copay Resolution; seconded by Mr. Wilson.
48 Mr. Bequette reminded committee members that the resolution still had to be approved by
49 the County Board. Upon vote, the **MOTION CARRIED** unanimously.

51 **V. Health Insurance Plan Renewal Discussion**

52
53 Ms. Garrett informed the committee that all other carriers have declined to bid, and she is
54 looking into “risk captive” and “association” plans. Ms. Garrett gave a general overview of
55 how the captive and association plans work.

57 Ms. Jett asked how much control the County would have over each option. Ms. Garrett
58 explained they would have more control with a captive plan, association plans would have
59 less choices and there are some associations Gallagher Insurance will not work with. Ms.
60 Jett clarified that this committee will still need to review plans each year if they go with an
61 association or captive plan.

63 Mr. Wilson asked why the committee had not heard these options before and mentioned
64 how burdensome a family plan is for a new employee at their starting salary. Committee
65 members mentioned their discussions from 2015 and 2017 regarding these same types of
66 plans. It was ultimately decided back then that it was too expensive, but this option may be
67 more palatable now.

69 Committee members requested information about how Health Savings Accounts (HSA)
70 work. Ms. Garrett provided details on HSAs, the different options, and how it could cost
71 the County more.

73 Ms. Jett asked for a breakdown of participants by age group; noting that we need to
74 increase enrollment of the younger employees. The committee then discussed the
75 potential of offering a bare bones plan for free or changing the premium cost to be
76 determined by salary grades. Several members expressed being in favor of these ideas,
77 but they may be an issue that needs to be bargained.

Ms. Garrett brought up the supplemental insurance plans; noting there is no increase for Delta Dental, we are still waiting to hear back from EyeMed and Reliance Standard is proposing a small increase for the first time in ten years. Ms. Ogden clarified that the Reliance Standard increase is for the County provided portion and not an increase on individual participants.

VI. Next meeting – August 19, 2025

The next meeting will be August 19, 2025.

Ms. Jett requested the bargaining units withdraw their grievances to ensure everything is wrapped up before the vote regarding the FY25 Copay Resolution goes to the County Board.
