












## Future Reimbursement Rate Issues

## Champaign County Rural Transit Advisory Group (RTAG) Annual Report 8-8-12

**Provider: CRIS Rural Transit (CRIS)** 

FY 1 Period: July 1st, 2011 - June 30th, 2012



Numbers below can be reconciled as needed (common in rural transit systems). IDOT-DPIT grants operate on IL Fiscal Year (July-June); therefore this RTAG reports cover the last completed fiscal year.

#### **Transit Services**

CRIS Rural Transit provides on-time dependable curb-to-curb <u>transit services</u> to residents of rural Champaign County, between 7:00am - 5:00pm Monday through Friday (except holidays). All drivers have been trained in passenger assistance and emergency procedures to insure that transportation services provided are safe, comfortable and secure. For general public (referred to as 5311) rural trips within the Rantoul Township High School District Area fares are \$2.00 and \$5.00 each way to or from Champaign-Urbana. If a passenger is disabled or 60 plus years of age the fare is a suggested donation of \$2.00 each way. Riders have to be over 11 years of age or older to ride unaccompanied by an adult. However, a child is accompanied by an adult; the fare is only \$1 additional each way. In Champaign County, CRIS employs 1 full-time safety associate (trainer/driver), 2 full-time dispatchers, and between 10 to 12 part-time drivers, in addition to 4 management staff positions that split their time working on Champaign and Vermillion County transportation that includes: one director of transportation, one billing clerk, one associate administrator, and one CEO.

#### **Champaign County Milestones**

To date, <u>milestones</u> for the rural Champaign County transit system operated by CRIS Rural Transit include:

- February 15<sup>th</sup>, 2011 first day of rural public transit.
- First Week of March new Urbana offices opened in partnership with Champaign-Urbana Transit to purchase at cost gas and vehicle maintenance, as well as rent vehicle facilities.
- August 2011 CRIS averaged 54 trips a day in Champaign County, which surpassed, a year in advance of, the 50 trips a day goal set by IDOT.
- January 2012 CRIS applied for New Freedom and JARC funding to increase countywide medical and job access transportation award announcements are still pending IDOT as of 8/1/12.
- April 2012 Champaign County received first startup funding vehicles, which included three mini-vans (i.e. 6-passenger) and two medium duty vehicles (i.e. 14-passenger).
  - o Prior to this, all vehicles were being rented from Vermillion County. Given the demand and need, Champaign County continues to rent vehicles from Vermillion County and has submitted several applications to purchase more vehicles.

#### **Trips** - In the table below, trip numbers reflect CRIS's provided transportation:

- Types of Trips Total number of trips, broken out and classified on destination per quarter. A return trip, to pick-up location was classified as the same purpose as the trip preceding it.
  - Example: If a rider is picked up, goes to the doctor's office (Trip A), then takes CRIS to a grocery store (Trip B) before returning home (Trip C); then the Trip A is medical, Trip B is shopping, and Trip C is shopping in purpose as well.
- □ **Total Trips** A trip is one unit of service (i.e. start and end point for one person, entering and exiting the vehicle).
- □ **Total Days** Total service days (M F) that CRIS was operating within a quarter (\* indicates holiday(s) occurred).
- Average Trips <u>Per Day</u> Total trips divided by total days.
- □ **Services Lift** trips are when an ADA lift was needed to be used. Riders can request to use the lift as needed, regardless if they use a mobility aid (examples: wheelchair, walker, or scooter). **60**+ trips indicate total senior rides provided.

#### **<u>Vehicles</u>** – The table below reflects the transit system's FY12 capacity though:

- Number of Vehicles used for transportation services within Champaign County (excluding service contract vehicles);
- 6, 12, & 14 passenger references number of rider seats per vehicle in service (all vehicle have an ADA lift); and
- Total Miles driven by vehicles within a month.

Note: If a vehicle was only utilized part of a month(s) within a quarter, then it counted as half or quarter based on number of days the vehicle was utilized. For example, in the first quarter, four (14 passenger) vehicles were used the whole time, and for one month an additional 14 passenger vehicle was utilized for services, which equals 4.25 vehicles for that quarter.

#### Each quarter's total of registered riders includes:

- □ **5311** A rider ends or begins a trip in a rural public service area of Champaign County.
- □ **5311D** A rider who is a person with one or more disability and therefore qualifies for the \$2 fare.
- RR (60+) A rural rider who is 60 years of age or older, and therefore qualifies for the \$2 fare. The senior discount trips previously was based at CCRPC senior services, called the Rural Rider Program.
- □ **Nursing Home** A rider who begins or ends their trip at the Champaign County Nursing Home.
