### Purpose of the Amendment

We are asking permission to move \$67,269 from the Miscellaneous Revenue Line and \$13,205 from the fund balance to the Contributions and Grants Line. These two transactions will result in an aggregate increase of \$80,474 to the Contributions and Grants line in order to meet contractual obligations for behavioral health services and supports through December 31, 2014. A listing of CCMHB contracts authorized by the Champaign County Mental Health Board is attached for your information.

If the budget amendment is not approved by the County Board, we will have to amend the contracts to reflect this reduction. The decision about which contracts will be reduced is the purview of the Champaign County Mental Health Board (CCMHB). Upon denial of this Budget Amendment (if that should be the decision), I will call a meeting of the CCMHB executive committee and discuss options to be brought to the full CCMHB meeting in October 2014.

#### Considerations

It is the policy of both the CCMHB and CCDDB to maximize allocations for direct services through our contracts with community-based service providers. In addition, CCMHB contracts, which total \$3,429,999, run from July 1 to June 30 in alignment with the State of Illinois fiscal year. We do this because most service providers with whom we contract also contract with the State of Illinois. Independent audits of provider contracts typically conform to the State of Illinois contract term.

Because the Champaign County Budget operates on the calendar year, the CCMHB contracts straddle two Champaign County fiscal (budget) years. This means when the CCMHB contract decisions are made in May, the contract maximums are predicated on estimates of what we anticipate revenue will be in the subsequent Champaign County Budget year. The combination of our funding maximization policy and the process of making estimates has historically resulted in the need for Budget Amendments during the course of the County fiscal/budget year.

As things stand, our requests for budget amendments will continue to occur from time to time in the future unless the CCMHB revises our policies. This could include shifting our contracts to align with the Champaign County fiscal year. If we were do this, the likelihood of future budget amendments would be eliminated, but this change would impair our ability to assure adequate fiscal accountability for our contracts.
