RESOLUTION APPROVING A MEMORANDUM OF UNDERSTANDING BETWEEN THE CHAMPAIGN COUNTY BOARD, AFSCME COUNCIL 31, LOCAL 900A, AND AFSCME GENERAL UNIT DOCUMENTING FY2015 ECONOMIC WAGE AND HEALTH INSURANCE TERMS AND EXTENSION OF CURRENT CONTRACT TO DECEMBER 31, 2015

WHEREAS, The Champaign County Board and the American Federation of Federal, State, County, and Municipal Employees Council 31, Local 900A have entered into a Collective Bargaining Agreement for the General Unit; and

WHEREAS, The Memorandum of Understanding - incorporated as Attachment A to this resolution - has been prepared with respect to the current General Unit Collective Bargaining Agreement between the County and AFSCME concerning the FY2015 economic wage and health insurance terms and the extension of current contract to December 31, 2015; and

WHEREAS, The Memorandum of Understanding shall not create any rights or obligations except as specifically stated therein, shall not create any obligation to bargain except as specifically stated therein, and shall not be considered a past practice for any purpose;

NOW, THEREFORE, BE IT RESOLVED by the County Board of Champaign County that the County Board Chair is hereby authorized and directed to execute the Memorandum of Understanding, as set forth in Attachment A to this resolution, modifying the General Unit Collective Bargaining Agreement with the American Federation of Federal, State, County, and Municipal Employees Council 31.

# MEMORANDUM OF UNDERSTANDING DOCUMENTING FY2015 ECONOMIC WAGE AND HEALTH INSURANCE TERMS AND EXTENSION OF CURRENT CONTRACT TO DECEMBER 31, 2015

Between AFSCME Council 31, Local 900A and the Champaign County Board, Champaign County Auditor, Champaign County Clerk, Champaign County Coroner, Champaign County Recorder, Champaign County Sheriff, and Champaign County Treasurer

The following documents amendments to the Agreement Between the above-named parties that was negotiated for the period December 1, 2011 through November 30, 2014.

## **ARTICLE XXIII - WAGES**

23.00 The Salary Scale minimums and maximums table is amended to add FY2015 as follows:

The following paragraph is added at the end of 23.00:

In FY2015, all employees of this unit shall receive a 2% adjustment to their current hourly rate on December 1, 2014. Additionally, all employee of this unit shall have \$0.09 added to their adjusted hourly rate in effect on December 1, 2014.

For those employees who, with the documented wage increase for FY2015 are above the maximum listed on the wage scale, will nonetheless receive the 2% and \$0.09 adjustment referenced above; however, there will be no adjustment to the actual scale. Any new hires or promotions of current Employees which occur during the term of this Agreement shall adhere to the above scale.

#### ARTICLE XXXIV – HEALTH AND LIFE INSURANCE

<u>**34.03** Employee Premium Cost Sharing:</u> (*The following sentence is added at the end of this section.*)

Beginning on January 1, 2015, employees shall pay \$26.80/monthly toward the single medical insurance premium cost, and the Employer shall pay the remaining balance of the premium cost.

<u>34.04 Dependent Premium Cost.</u> (The following sentence is added at the end of this section.) Beginning on January 1, 2015, the County will contribute an additional thirty dollars (\$30) monthly over the current Employer contribution defined in 34.03 toward the medical insurance premium costs of the dependent coverage plan selected by the employee.

# <u>Article XLVII – TERM OF THE AGREEMENT</u>

<u>47.00</u> The ending date for the Term of the Agreement is amended from November 30, 2014 to December 31, 2015.

This Memorandum does not alter any other contractual provisions of this Collective Bargaining Agreement.
