The Champaign County Mental Health Board will have a budget amendment on the Champaign County Board's February 18 Meeting Addendum. This Budget Amendment deals with the CILA Homes that the Mental Health Board has purchased in Fiscal Year 2015.

For background information, Community Integrated Living Arrangement (CILA) is a living arrangement for adults (age 18 and older) in a group home, family home or apartment where 8 or fewer unrelated adults with developmental disabilities live under supervision of the community developmental services agency. Residents receive complete and individualized residential habilitation, personal support services and supports under the direction of a community support team within the local agency. The Mental Health Board, with financial support of the Developmental Disabilities Board, has purchased two homes for this purpose, and plans to add more in the future.

The Mental Health Board has contracted with an agency to operate the CILA Homes. Additionally, a property manager has been contracted with to manage the physical upkeep of the homes.

This week, in preparation for the Fiscal Year 2015 Audit, CliftonLarsonAllen, LLP, the county's outside audit firm, has requested that the County add these homes, and related expenses, to our financial system. In order to book the purchase of the homes and the expenses related to the upkeep and maintenance of the homes in the financial system, a budget amendment is in order. In addition to the expenditures made on the homes, revenue provided by a Debenture Loan from PNC Bank, as well as rent received as these homes are occupied, is included in this budget amendment.

This action will reflect the income and expenditures already made in Fiscal Year 2015, there is no additional expense or spending authority granted to the Mental Health Board with this action. This action will bring the County into compliance with GAAP standards.

In the future, similar budget amendments will happen on an annual basis, following the close of the fiscal year.

The Mental Health Board has worked with the County Auditor's Office since the onset of the CILA project to assure full understanding and compliance with Champaign County fiscal policies. We now request passage of this budget amendment at your February 18 meeting so that progress on the Fiscal Year 2015 audit is not impeded.
