WHEREAS, Amendment #1 is a minor amendment to LRMP Volume 1 Existing Conditions and Trends Report. Chapter 10: Natural Resources, Water Quality Section to include information about the Champaign County MS4 Storm Water Management Program;

WHEREAS, Amendment #2 contains minor changes to the LRMP Volume 2 Land Use Management Areas Map to update municipal and 1 1/2 mile extraterritorial jurisdiction boundaries;

WHEREAS, these minor amendments proposed are consistent with LRMP Policy 1.3.1: ELUC will recommend minor changes to the LRMP after an appropriate opportunity for public input is made available";

# A RESOLUTION AUTHORIZING THE RENAMING OF CERTAIN PARTS OF EXISTING NORTH LINCOLN AVENUE

WHEREAS, the Champaign County Board adopted Resolution No. 3158 establishing a system of rural addressing and city address service areas on 12/17/91; and

WHEREAS, Champaign County Board Resolution No. 3158 authorizes the Champaign County Administrator to report on existing and potential cases of confusing street and road names and to make recommendations for appropriate changes; and

WHEREAS, the realignment of North Lincoln Avenue that is currently under construction is expected to open to traffic sometime in the fall of 2017 and the opening of the realigned North Lincoln Avenue will result in certain parts of existing North Lincoln Avenue that will continue to be public streets but that will need to be renamed to prevent confusion in addressing with the new North Lincoln Avenue; and

WHEREAS, land for the realignment of North Lincoln Avenue and the related extension of Olympian Drive was formerly part of Squire Farms, a Centennial Farm; and

WHEREAS, the Champaign County Administrator has recommended and the Environment and Land Use Committee has recommended to this Board to rename the portion of existing North Lincoln Avenue that connects to West Oaks Road as "West Oaks Road"; and to rename the North-South portion of existing North Lincoln Avenue as "Squire Farm Road"; and to rename the portion of existing North Lincoln Avenue that will connect to the new realigned North Lincoln Avenue as "Centennial Farm Road", all as shown on the attached map; and

WHEREAS, the proposed street name "Squire Farm Road" is inconsistent with the *Champaign County Incorporated Area Street Addressing Standards* because "Squire Farm Road" is a duplicate primary street name because the word "Squire" has already been used to name both "Squire Place" and "Squire Court" in the City of Urbana and duplicate primary street names are prohibited by Section 2.4.1a. of the *Champaign County Incorporated Area Street Addressing Standards* because duplicate primary street names can lead to confusion at the time of emergency dispatch and can result in unnecessary delays for emergency responders that could put landowners at risk; and

WHEREAS, other street names were considered by the Environment and Land Use Committee but "Squire Farm Road" was requested by more of the affected landowners and the landowners are aware of the risks inherent in a duplicate primary street name; and

WHEREAS, METCAD reviews all proposed addresses and street names to ensure consistency in emergency dispatching and METCAD has agreed not to oppose the use of "Squire Farm Road"; and WHEREAS, the Champaign County Board may authorize the use of a duplicate primary street name that is inconsistent with the *Champaign County Incorporated Area Street Addressing Standards*, when METCAD does not oppose the use of that particular duplicate street name; and


NOW, THEREFORE BE IT RESOLVED by the Champaign County Board that:

- 1. As shown on the attached map, the portion of existing North Lincoln Avenue that connects to West Oaks Road is hereby authorized to be renamed to "West Oaks Road" and the North-South portion of existing North Lincoln Avenue is hereby authorized to be renamed to "Squire Farm Road" and the portion of existing North Lincoln Avenue that connects to the new re-aligned North Lincoln Avenue is hereby authorized to be renamed to "Centennial Farm Road", and all renaming shall be at an appropriate time coordinated with the opening of the newly realigned North Lincoln Avenue and in coordination with the installation of new street signs; and
- 2. At the appropriate time, the Champaign County Engineer shall cause the contractor constructing the realignment of the North Lincoln Avenue to install new road signs with the new names of these streets; and
- 3. At the appropriate time, the Champaign County GIS Consortium shall enter the new names for these streets in the Champaign County GIS data; and
- 4. At the appropriate time, the Zoning Administrator shall send an Address Change Notification to each affected landowner and to all affected agencies.
