County does send people to specialized schools. Sometimes it is thru our local Training Unit (no extra charge), but often we have to pay for the school. Such schools include: basic K9, Advanced K9, Crisis Intervention Team (Mental Health), Mental Health First Aid, Taser instructor, Rifle Instructor, Firearms Instructor, Field Training Officer, various SWAT schools, SWAT monthly training, Control Tactics Instructor, Supervisors School, Management Schools, forensic schools (Crime Scene) etc. Law Enforcement is a multidisciplinary task. Like other professionals, we have to keep up the skill levels. We do not have our own range so we sometimes rent range time and we also have to pay a private vendor for the shoot/don't shoot computer generated training.
