After reviewing the information provided by IGW Architecture, I agree with their recommendation for the acceptance of the bid from Otto Baum Company Inc of Morton Illinois for the base bid and the bid for Alternate #2. The addition of the alternate bid #1 will put us over the budgeted amount and should not be included at this time.

RECOMMENDATION

The County Facilities Committee requests the Full County Board to enter into an agreement with Otto Baum Company Inc. to perform the work at the Champaign County Courthouse outlined in the base bid and the alternate bid #2 for a total of \$135,745.

Dear Kirk:

Bids were opened on September 11, 2013 at 2:00 pm for the referenced project. Five Contractor bids were received for the project which included a base bid and two alternate bids. The apparent low bidder for the base bid plus alternate #2 is Otto Baum Company out of Morton Illinois with a total of \$135,745. This compares to a project construction budget of \$223,340. If the base bid and both alternates were accepted Evan-Mason Inc would be the apparent low bidder with a total of \$239,565 which would be \$16,225 over budget.

We talked to Otto Baum and they are comfortable with their bid. Alternate bid#1 is for the replacement of the existing stairs and ramp on the south side of the existing courthouse that are in poor condition. This scope of work was not part of the original project but was designed and bid so that the County would have a good budget figure for their use in the future. Alternate #2 is for cleaning and sealing the exterior masonry on the Courthouse Addition south and west sides. This work was part of the original budget but was added in case the bids came in above budget. The bid results are attached.

Based on our review of the General work bids, we recommend that the County Board award a contract to Otto Baum Company Inc for the base bid plus Alternate bid #2 for a total of \$135,745.
