A. Discussion of Study Presented by Reifsteck & Reid Architecture

Recently, Mr. Brenner contacted Mr. Reifsteck to update the last summary of those studies as well as to receive input from Champaign County Sheriff and his staff. Mr. Reifsteck updated everyone on the study and reviewed a slide presentation of the public safety facilities. Discussion was held on the cost to complete the project of combining the Downtown Jail with the Satellite Jail and the goals of the study.

## B. Update on ITB#2019-001 Art Bartell Sidewalk Project

Mr. Brenner updated the status of the Sidewalk Project and reviewed the handout that was given. The Art Bartell Sidewalk Project is down to some fine grading and top soiling of some areas. Later this month, the process of seeding will begin. The last stage is the placement of the sign and lighting for Lierman and Art Bartell. Ameren Illinois will place a meter and Aladdin Electric will supply placement for electrical line. The sidewalk is currently being used by the public.

## C. Update on OITB#2019-002 JDC Roof Replacement Project

Mr. Brenner reviewed pictures of the Roof Replacement Project. Rain has effected the progress of the roof replacement. Four sections have been replaced. The project is moving along nicely. Minimum leaks have been addressed. Mr. Brenner anticipates the project with Advanced Commercial Roofing to be finalized by end of month.
