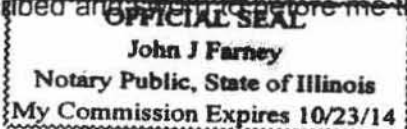

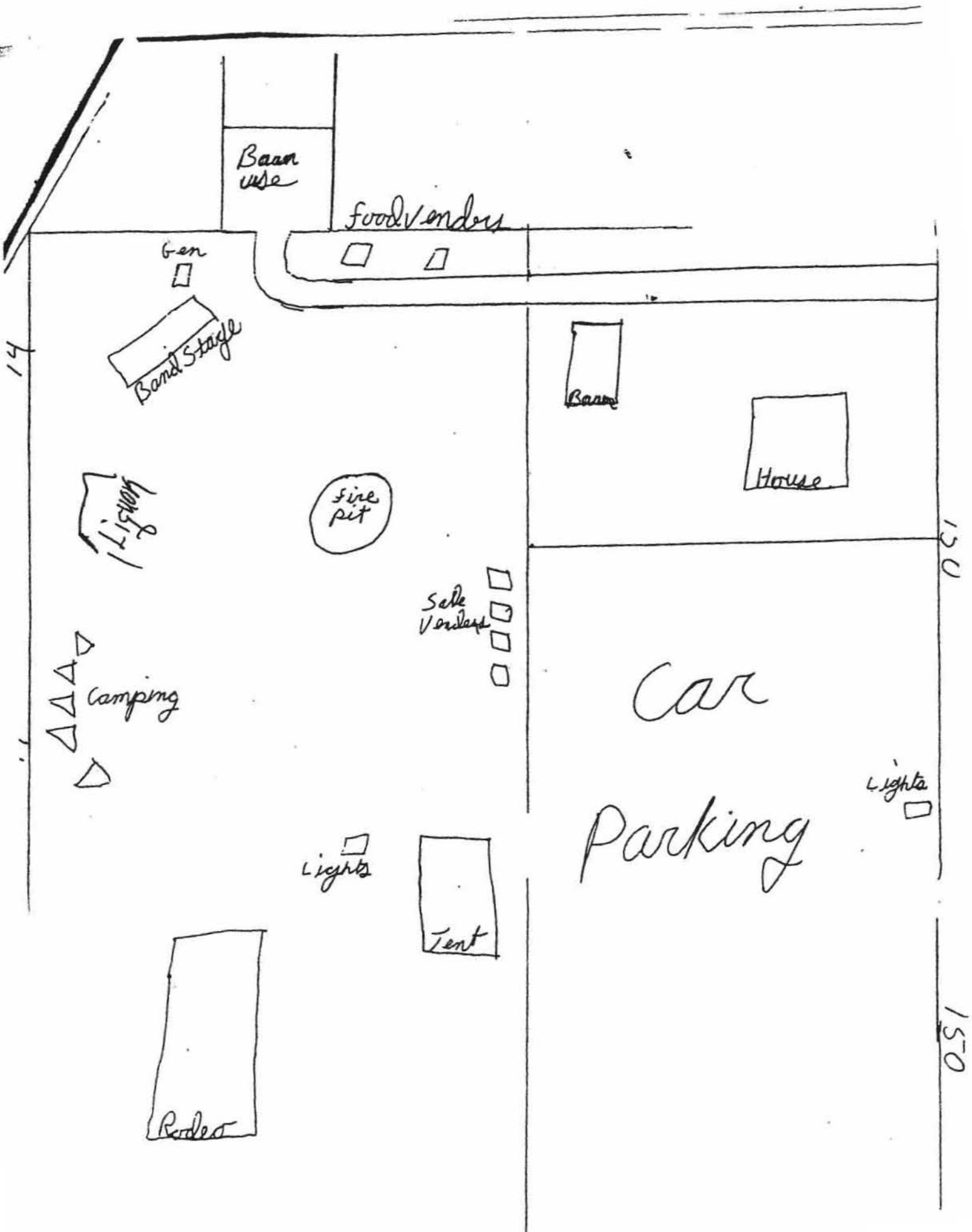

4. Rent

The rental for said property shall be \$ 1000, due and payable by check on 06/03/2012

5. Utilities

Owner agrees to furnish the following services and/or utilities: electricity, water, trash collection

In addition it is agreed:

1. Owner may enter the premises at reasonable times for the purpose of inspection, maintenance, repair or prospective tenants.
2. Tenant agrees to occupy the premises and shall keep the same in good condition; reasonable wear and tear expected, and shall not make any alterations thereon without the consent of the Owner.
3. Tenant shall, upon termination of this Agreement, vacate and return property in the same condition that it was received, less reasonable wear and tear, and other damages beyond the Tenant's control.
4. In a dispute between the Owner and Tenant which gives rise to any action in court, the losing party will pay the court costs and reasonable attorney fees of the successful party.
