A RESOLUTION APPOINTING INTERIM SUPERVISOR OF ASSESSMENTS For CHAMPAIGN COUNTY

WHEREAS, pursuant to the resignation of Joe Meents, Champaign County Supervisor of Assessments, the office of Supervisor of Assessments became vacant on January 13, 2016; and

WHEREAS, Mark Whitsitt is a Certified Illinois Real Estate Appraiser; and

WHEREAS, on January 21, 2016, the Champaign County Board appointed Mark Whitsitt as Interim Champaign County Supervisor of Assessments for a term from January 22, 2016 to March 17, 2016; and

WHEREAS, the Champaign County Board seeks to again appoint Mark Whitsitt as Interim Champaign County Supervisor of Assessments for a term from March 18, 2016 to April 1, 2016 to fulfill the responsibilities of said position until the newly appointed Champaign County Supervisor of Assessments takes office on April 4, 2016; and

WHEREAS, the compensation to be paid to Mark Whitsitt in his role as Interim Supervisor of Assessments from March 18, 2016 to April 1, 2016 shall be paid on the pro rata basis of an annual salary of \$62,185.50;

NOW, THEREFORE BE IT RESOLVED by the County Board of Champaign County that Mark Whitsitt is appointed as Interim Champaign County Supervisor of Assessments to serve for a period from March 18, 2016 to April 1, 2016; and

BE IT FURTHER RESOLVED by the County Board of Champaign County that the compensation to be paid to Mark Whitsitt in his role as Interim Supervisor of Assessments from March 18, 2016 to April 1, 2016 shall be paid on the pro-rata basis of an annual salary of \$62,185.50; and

BE IT FURTHER RESOLVED by the County Board of Champaign County that the County Clerk of the County of Champaign is hereby directed to forward two certified copies of this Resolution to the Illinois Department of Revenue.
