Budget Amendment to MHB/DDB CILA Facilities Fund (101)

Date: May 4, 2016

The Champaign County Mental Health Board has a Budget Amendment on the Champaign County Board's May Finance Committee of the Whole Addendum. This Budget Amendment deals with the CILA Homes that the Mental Health Board has purchased over the last two years.

For background information, Community Integrated Living Arrangement (CILA) is a living arrangement for adults (age 18 and older) in a group home, family home or apartment where 8 or fewer unrelated adults with developmental disabilities live under supervision of the community developmental services agency. Residents receive complete and individualized residential habilitation, personal support services and supports under the direction of a community support team within the local agency. The Mental Health Board, with financial support of the Developmental Disabilities Board, has purchased two homes for this purpose, and plans to add more in the future.

Throughout the last two years, the Mental Health Board and County Auditor's Office have worked together to create the most transparent, efficient and thorough financial reporting system possible for the CILA Project. In order to achieve those goals, the County Auditor's Office is recommending that a separate Fund be created in the County Budget under control of the Mental Health Board to segregate funds for CILA homes from other Mental Health Board funds. Creating a separate Fund will allow for complete transparency, quick and easy reconciliation of accounts, better budgeting and allows for additional reporting on those funds.

To facilitate the creation of this new Fund, a Budget Amendment by the County Board is necessary to allocate budgeted funds from the Mental Health Board (090) to the new Fund, MHB/DDB CILA Facilities (101). This Amendment does not grant any additional spending authority during FY2016.
