### **MEMORANDUM**

TO: Members of the Champaign County Board

DATE: March 8, 2018

RE: Board Budget Amendment\_18-09

The increased appropriations requested in Budget Amendment 18-09 will be used to fund the creation of a temporary part-time coordinator position for the Residential Foreclosure Mandatory Mediation Program. The Foreclosure Mediation Fund was established for this program in FY2017.

These responsibilities were initially intended to be covered by a memorandum of understanding between Champaign County and an independent contractor, but that arrangement was unsuccessful.
