STATUS

On February 6, 2017, staff received a final response from the Illinois Department of Natural Resources regarding its evaluation and recommendations for protecting endangered species that could be affected by development on the subject property.

On February 7, 2017, staff received an email from Chris Marx, City of Urbana Planner, that stated the City will not protest the rezoning for Case 858-AM-16.

IDNR CONSULTATION AND RECOMMENDATIONS

As noted in the previous memorandum, on December 8, 2016, staff initiated a formal consultation process with the Illinois Department of Natural Resources (IDNR) regarding the impact of the proposed map amendment and special use on the Barnhart Prairie and the Franklin Ground Squirrel.

On January 11, 2017, IDNR representative Natalia Jones visited the subject property and adjacent Illinois Nature Preserve. She spoke with co-petitioner Abigail Frank during the visit regarding the Franklin Ground Squirrel habitat that is located where the grass parking area was proposed in the original Site Plan. The petitioners decided to propose a different parking area, northeast of the event center, and were told by IDNR that the proposed area would not be a concern.

On February 6, 2017, the Zoning Department received the Natural Resources Consultation Termination Letter from the Illinois Department of Natural Resources. The letter (see attachment) included a list of recommendations that would help protect the Franklin Ground Squirrel habitat on the subject property, as follows:

- 1. An ~8 foot buffer should be created between the proposed Bluestem Drive and the prairie boundary to minimize the possibility of species roadkill. The buffer should be mowed regularly and grass heights should not exceed ~4 inches with first mowing occurring before April 1st if weather conditions allow:
- 2. All personnel working on site should be advised of the species presence and taught to recognize juvenile and adult Franklin's Ground Squirrels. If the species is encountered, crews should stop work immediately and allow the squirrel to move away;

- 3. A speed limit sign should be installed by the entrance to Bluestem Drive;
- 4. Any disturbance to a vegetated strip on the East side of the property along the proposed parking lot will result in incidental taking which is a violation of the Illinois Endangered Species Protection Act;
- 5. If you wish to enhance the species habitat, construction of a berm or dirt pile will be beneficial. The species is likely to utilize any vegetated stockpiles (except clay). Please contact IDNR Biologist Eric Smith at 217-784-4730 ext. 225 for any additional information;
- 6. Strict adherence to best management practices for erosion and sedimentation control measures should be used to minimize the possibility of any adverse impacts to the Nature Preserve.

Staff forwarded the letter to petitioner Abigail Frank, and on February 6, 2017, staff received her response (see attachment). She indicated that she agrees to implement all recommendations.

Had this IDNR consultation been completed within the anticipated timeline, staff would have included a Special Condition of approval based on these recommendations. As it stands, the Special Use Permit for the event center was approved by the ZBA without this condition. Nonetheless, a condition can still be added to the rezoning if ELUC and the County Board desire.

PROPOSED SPECIAL CONDITIONS

The following special condition was recommended by the ZBA for Case 848-AM-16:

A. The owners of the subject property hereby recognize and provide for the right of agricultural activities to continue on adjacent land consistent with the Right to Farm Resolution 3425.

The above special condition is necessary to ensure the following:

Conformance with Land Resource Management Plan Policy 4.2.3.

Based on the IDNR recommendations, the following Special Condition of approval is recommended for the rezoning. All special conditions must be agreed to by the petitioner and that agreement should be reflected in the meeting minutes.

- B. The petitioner shall abide by the recommendations of the Illinois Department of Natural Resources (IDNR) Endangered Special Consultation letter dated February 6, 2017, for Bluestem Hall (IDNR Project Number 1705136 [858-AM-16], which are the following:
 - (1) An ~ 8 foot buffer should be created between the proposed Bluestem Drive and the prairie boundary to minimize the possibility of species roadkill. The buffer should be mowed regularly and grass heights should not exceed ~ 4 inches with first mowing occurring before April 1st if weather conditions allow.
 - (2) All personnel working on site should be advised of the species presence and taught to recognize juvenile and adult Franklin's Ground Squirrels. If the

- species is encountered, crews should stop work immediately and allow the squirrel to move away.
- (3) A 15 mile per hour or less speed limit sign should be installed by the entrance to Bluestem Drive;
- (4) There will be no disturbance to an existing vegetated strip on the east side of the property along the proposed parking lot; disturbance will result in incidental taking which is a violation of the Illinois Endangered Species Protection Act.
- (5) Strict adherence to best management practices for erosion and sedimentation control measures should be used to minimize the possibility of any adverse impacts to the Nature Preserve.

The special condition stated above is required to ensure the following:

The establishment of the proposed use shall be compliant with Illinois Department of Natural Resources regulations and recommendations.

This letter concerns the Endangered Species Consultation for the project noted above, located in Champaign County, Township 18 North, Range 9 East, Sections 4. This project was submitted for consultation in accordance with the Illinois Endangered Species Protection Act [520 ILCS 10/11], the Illinois Natural Areas Preservation Act [525 ILCS 30/17], and Title 17 Illinois Administrative Code Part 1075.

The project consists of conversion of a barn to a wedding/event center.

The Department has completed its review of the project and determined that, with the exception below, the resources identified by EcoCAT in the vicinity are unlikely to be affected.

The state-threatened Franklin's Ground Squirrel (Poliocitellus franklinii) is known to occur in the vicinity of the proposed project area. To minimize possible impact to the species, the Department recommends the following measures be incorporated into the project:

- An ~ 8 foot buffer should be created between the proposed Bluestem Drive and the prairie boundary to minimize the possibility of species roadkill. The buffer should be moved regularly and grass heights should not exceed ~ 4 inches with first moving occurring before April 1st if weather conditions allow;
- All personnel working on site should be advised of the species presence and taught to recognize juvenile and adult Franklin's Ground Squirrels. If the species is encountered, crews should stop work immediately and allow the squirrel to move away;
- A speed limit sign should be installed by the entrance to Bluestem Drive;
- Any disturbance to a vegetated strip on the East side of the property along the proposed parking lot will result in incidental taking which is a violation of the Illinois Endangered Species Protection Act;

- If you wish to enhance the species habitat, construction of a berm or dirt pile will be beneficial. The species is likely to utilize any vegetated stockpiles (except clay). Please contact IDNR Biologist Eric Smith at 217-784-4730 ext. 225 for any additional information;
- Strict adherence to best management practices for erosion and sedimentation control
 measures should be used to minimize the possibility of any adverse impacts to the
 Nature Preserve.

Consultation under 17 Ill. Adm. Code Part 1075 is completed. In accordance with 17 Ill. Adm. Code 1075.40(h), please notify the Department of your decision regarding these recommendations.

This consultation is valid for two years unless new information becomes available that was not previously considered; the proposed action is modified; or additional species, essential habitat, or Natural Areas are identified in the vicinity. If the project has not been implemented within two years of the date of this letter, or any of the above listed conditions develop, a new consultation is necessary.

The natural resource review reflects the information existing in the Illinois Natural Heritage Database at the time of the project submittal, and should not be regarded as a final statement on the site being considered, nor should it be a substitute for detailed site surveys or field surveys required for environmental assessments. If additional protected resources are encountered during the project's implementation, you must comply with the applicable statutes and regulations. Also, note that termination does not imply IDNR's authorization or endorsement of the proposed action.
