Ryan Ackerman, Kerr Township Road Commissioner expressed his concerns for Kerr Township roads in Champaign County. Mr. Ackerman stated that he was recently contacted by a representative from Parks Livestock regarding two proposed sites for hog facilities in Kerr Township. Mr. Ackerman said he is concerned the township roads cannot handle the traffic especially during the construction of the facilities. He said Kerr Township is one of the smallest townships in the County and he does not want the roads to suffer. Mr. Ackerman provided maps of where the proposed sites would be located. Mr. Blue said he talked to John Hall from the County's Planning & Zoning and he said state statutes regulate the hog facilities. Mr. Blue said the County could request a public hearing. Mr. Blue agreed to meet with Mr. Ackerman and an outside attorney to discuss road use agreements for the township. The committee agreed that Mr. Blue and Mr. Ackerman should discuss the issue with an attorney before meeting with Parks Livestock.

PETITION

Petitioner, <u>Jeff White</u>, hereby requests an appropriation of funds from the Champaign County Bridge Fund pursuant to 605 ILCS 5/5-50l. In support of this petition, Petitioner states the following:

- 1. Petitioner is the duly elected Highway Commissioner for the <u>Colfax</u> Road District, Champaign County, Illinois; and
- 2. There is a <u>bridge</u> located <u>between Sections 5 & 8</u>, which is in poor condition and is inadequate to serve the needs of the traveling public; and
- 3. To ensure the adequacy of said structure for the traveling public, it is necessary that said structure be <u>repaired</u>; and
- 4. The cost of <u>repairing</u> the aforesaid structure is estimated to be \$17,500.00, which will be more than .02% of the value of all the taxable property in the <u>Colfax</u> Road District, as equalized or assessed by the Department of Revenue; and
- 5. The tax rate for road purposes in the <u>Colfax</u> Road District was in each year for the last two (2) years not less than the maximum allowable rate provided for in Section 6-501 of the Illinois Highway Code (605 ILCS 5/6-501); and
- 6. The <u>Colfax</u> Road District is prepared to pay one-half of the cost of the <u>repair</u> of said structure.

WHEREAS, the County Board finds that based on the representations in the attached Petition, it required pursuant to 605 ILCS 5/5-501 to provide the requested aid.


NOW, THEREFORE, BE IT RESOLVED by the County Board of Champaign County as follows:

- 1. The County Board hereby appropriates from the County Bridge Fund a sufficient sum to meet one-half the cost of repairing the structure.
- 2. The County Board hereby directs the County Engineer to cause plans and specifications to be prepared for said improvements.
- 3. The County Board hereby orders that said improvement be made under the general supervision of the County Engineer, by receiving quotes for the improvements.
- 4. The County Board hereby directs the County Engineer to certify to the County Board when the work has been satisfactorily completed to meet his or her approval. Such certificate shall include an itemized account of the cost of all items of work incurred in the completion of said improvements, and shall show the division of cost between the County and the Colfax Road District.
- 5. The County Board further directs the County Engineer to file said certificate with the clerk of the <u>Colfax</u> Road District.
 - 6. This Resolution shall become effective upon its adoption.

RESOLUTION APPROPRIATING \$60,000.00 FROM COUNTY BRIDGE FUNDS FOR A CULVERT REPLACEMENT LOCATED ON COUNTY HIGHWAY \$19 SECTION \$18-00049-00-BR

WHEREAS, There is a culvert on County Highway 19 (Sadorus) located between Section 13 and 18 in poor condition, which is endangering the safety of the traveling public; and

WHEREAS, To insure the safety of the traveling public, it is necessary that said culvert be replaced; and

WHEREAS, The cost of replacing of the aforesaid culvert, which shall include construction and design engineering, is estimated to be \$60,000.00; and

WHEREAS, The Highway and Transportation Committee recommends that said replacement be made; and

WHEREAS, The County Board of Champaign County concurs in the action recommended by the Committee;

NOW, THEREFORE, BE IT RESOLVED, That there is hereby appropriated the sum of Sixty Thousand Dollars (\$60,000.00) from County Bridge Funds for this replacement.
