54		County Road and Bridge Projects that may qualify for a capital bill through the state legislature. Mr.
55		Blue said there is a lot of discussion regarding transportation funding at the state and national level. The
56		Motor Fuel Tax rate for the State of IL has not been changed since 1990. The projects discussed include
57		the rebuild of sections of County Highway 9, 15, and 18. The replacement of bridge #010-0119 located
58		on CH 18, the replacement of bridge #010-0080 located on CH 15, the replacement of bridge #010-4033
59		located on High Cross Road, and the replacement of bridge #010-0122 located on CH 17. Maps were
60		provided to show the location of the projects.




