#### I. Call to Order

Committee Chair Cowart called the meeting to order at 9:02 a.m.

A verbal roll call was taken and a quorum was declared present.

### VII. County & Township Motor Fuel Tax Claims – August 2019

**MOTION** by Mr. Clemmons to receive and place on file the County and Township Motor Fuel Tax Claims for August 2019; seconded by Mr. McGuire.

Upon vote, the **MOTION CARRIED unanimously**.

Mr. Blue stated he would like to replace 2 bridges on County Highway 1 (Dewey-Fisher Road) that are  $\frac{1}{2}$  mile apart in the same year to only disrupt traffic once. He said the County does not have enough County Bridge Funds for the projects and would like to focus the additional Motor Fuel Tax Funds on updating structures.

# X. Resolution Appropriating County Bridge Funds for the Rehabilitation of Structure #010-4125 on County Highway 11, #19-00080-00-BR

Mr. Blue discussed a bridge that needs replaced on County Highway 11. He said he would like to replace the superstructure next year however he is not sure how long the environmental services will take since the manpower has been downgraded at the state level. The bridge replacement is estimated to cost \$750,000.00.

# XI. Petition Requesting and Resolution Approving Appropriation of Funds from the County Bridge Fund, Tolono Township, #19-29081-00-BR

Mr. Blue discussed a petition and resolution for Tolono Township. Since Mr. Blue is on the Executive Committee of NACE, and Short Span Steel Alliance is a sponsor of NACE, they are trying to get a new type of structure approved within the State of Illinois. A location in Tolono Township has been approved as a site for the new structure. If the project is approved by the County Board the County Bridge will be pay for the engineering services and the construction cost will be split 50/50 between County Bridge Funds and Tolono Township.

# XII. Resolution Authorizing the County Executive to Enter into an Intergovernmental Agreement with Tolono Township Road District

Mr. Blue discussed a section of County Highway 25 in Tolono Township that the Tolono Road District has been maintaining. Mr. Blue said the portion of County Highway 25 is not appropriate to be plowed with a County plow truck. The agreement states that the Tolono Road District will assume responsibility for snow removal on the section of Champaign County Highway 25 immediately west of Staley Road beginning at Old Church Road and continuing approximately one-thousand feet south which provides access to Moraine View Subdivision.

# XIII. Petition Requesting and Resolution Approving Appropriation of Funds from the County Bridge Fund, Harwood Township, #19-11082--00-BR

Mr. Blue informed the committee that a large box culvert located between sections 22 & 23 in Harwood Township needs replaced. The estimated cost is \$40,000.00 and will be split 50/50 between County Bridge Funds and Harwood Township.
