74	XI.	FY 2023 Budget Review
75		Mr. Blue discussed the Highway Department funds highlighting the revenue sources for each
76		fund and explaining the major expense categories. The Highway Fund receives revenue
77		primarily from property taxes. He explained that the Highway Fund budget is used primarily for
78		personnel, maintenance, heavy equipment purchases, and everyday expenses. He explained
79		that each year funds are set aside for the Highway Building Capital Fund. This is where funds
80		accumulate until capital repairs are necessary.
81		
82		Next, he discussed the County Bridge Fund. The revenue for this fund is from property taxes
83		and the funds are used to fix and replace bridges and culverts. There are 2 bridges in
84		Champaign Township and a bridge in Ludlow Township that are scheduled for re-decking next
85		summer. Also, a bridge in Pesotum Township needs rebuilt as soon as approval is given by the
86		State Historic Preservation Office.
87		State historic rreservation office.
88		The revenue from the State of Illinois gas tay is denosited into the Motor Fuel Tay Fund for read
89		The revenue from the State of Illinois gas tax is deposited into the Motor Fuel Tax Fund for road and bridge maintenance and improvements. There are 3 projects scheduled for fiscal year
90 01		2023. These include a cold in place recycle on County Highway 12, a cold in place recycle with
91 02		hot mix overlay on County Highway 24, and a bridge deck replacement on County Highway 6.
92 02		He also explained the need to budget for County Highway 18 right of way expenses.
93		
94 05		The Federal Aid Matching Fund property tax revenue is set aside to match Federal projects that
95		require local matching funds. The fund balance will be used in fiscal year 2024.
96		
97		Lastly, he discussed the IDOT REBUILD Grant. Champaign County received 5.8 million dollars of
98		REBUILD funds which must be spent by 2025. Champaign County will expend this fund by the

99		end of 2023. The balance of this fund will be used for a bridge replacement on County Highway
100		32.
101		
102		The committee discussed road conditions in Champaign County and the scheduled
103		improvements.
104		
105		Mr. Blue stated the price for salt this year is \$109.50 per ton.
106		
107	XII.	Other Business
108		Mr. Blue said the Highway Department will have an employee recognition luncheon. Once the
109		date is set, he will send an invite to the Highway Committee members.

111		Ms. Michaels discussed stop signs in rural Thomasboro.

113		Ms. Straub asked if anyone from Urbana had contacted Mr. Blue regarding putting a school in
114		the unincorporated area of town.

### PETITION REQUESTING AND RESOLUTION APPROVING APPROPRIATION OF FUNDS FROM THE COUNTY BRIDGE FUND PURSUANT TO 605 ILCS 5/5-501

#### **PETITION**

Petitioner, <u>Scott Rodgers</u>, hereby requests an appropriation of funds from the Champaign County Bridge Fund pursuant to 605 ILCS 5/5-501. In support of this petition, Petitioner states the following:

1. Petitioner is the duly elected Highway Commissioner for the <u>East Bend</u> Road District, Champaign County, Illinois; and

2. There is a <u>culvert</u> located <u>in Sections 28</u>, which is in poor condition and is inadequate to serve the needs of the traveling public; and

3. To ensure the adequacy of said structure for the traveling public, it is necessary that said structure be <u>replaced</u>; and

4. The cost of <u>replacing</u> the aforesaid structure is estimated to be <u>\$39,950.00</u>, which will be more than .02% of the value of all the taxable property in the <u>East Bend</u> Road District, as equalized or assessed by the Department of Revenue; and

5. The tax rate for road purposes in the <u>East Bend</u> Road District was in each year for the last two (2) years not less than the maximum allowable rate provided for in Section 6-501 of the Illinois Highway Code (605 ILCS 5/6-501); and

6. The <u>East Bend</u> Road District is prepared to pay one-half of the cost of the <u>replacement</u> of said structure.

#### **RESOLUTION NO.**

WHEREAS, the County Board finds that based on the representations in the attached Petition, it is required pursuant to 605 ILCS 5/5-501 to provide the requested aid.

NOW, THEREFORE, BE IT RESOLVED by the County Board of Champaign County as follows:

1. The County Board hereby appropriates from the County Bridge Fund a sufficient sum to meet one-half the cost of <u>replacing</u> the structure.

2. The County Board hereby directs the County Engineer to cause plans and specifications to be prepared for said improvements.

3. The County Board hereby orders that said improvement be made under the general supervision of the County Engineer, by receiving quotes for the improvements.

4. The County Board hereby directs the County Engineer to certify to the County Board when the work has been satisfactorily completed to meet his or her approval. Such certificate shall include an itemized account of the cost of all items of work incurred in the completion of said improvements and shall show the division of cost between the County and the <u>East Bend</u> Road District.

5. The County Board further directs the County Engineer to file said certificate with the clerk of the <u>East Bend</u> Road District.

6. This Resolution shall become effective upon its adoption.



#### RESOLUTION APPROPRIATING \$6,000,000.00 FROM CHAMPAIGN COUNTY MOTOR FUEL TAX FUND FOR THE IMPROVEMENT OF COUNTY HIGHWAY 12 & COUNTY HIGHWAY 24 SECTION #22-00460-00-RS

WHEREAS, County Highway 12 beginning at County Highway 20 and extending to County Highway 11 a distance of approximately 4 miles, and County Highway 24 beginning at US 150 and extending to County Highway 20 a distance of 5 miles, in Champaign County are in need of improvement; and

WHEREAS, These two roadways are to be improved under one contract; and

WHEREAS, The type of improvement shall consist of cold recycling with an asphalt overlay and aggregate shoulders and shall be designated as Section #22-00460-00-RS.



# County Road 12 CIR Job






