I. Call to Order

Committee Chair Cowart called the meeting to order at 9:06 a.m.

II. Roll Call

A verbal roll call was taken, and a quorum was declared present.

III. Approval of Agenda/Addendum

MOTION by Ms. Carter to approve the agenda; seconded by Ms. Taylor. Upon vote, the **MOTION CARRIED unanimously.**

MOTION by Ms. Straub to approve the minutes of the November 4, 2022 meeting; seconded by Ms. Taylor.

VI. Communications

Ms. Carter asked about establishing a Vision Board for the Highway Committee to set goals regarding minority participation in Highway projects. Mr. Blue stated that state and federal projects have goals already set in the contracts. Mr. Blue agreed to email a copy of a contract to the Highway Committee members.

VII. County & Township Motor Fuel Tax Claims-November and December 2022

MOTION by Ms. Straub to receive and place on file the County and Township Motor Fuel Tax Claims for November and December 2022; seconded by Ms. Carter. Upon vote, the **MOTION CARRIED unanimously.**

VIII. Rock Letting Results

Mr. Blue discussed the aggregate bid results from the rock letting held for the Champaign County Townships on December 8, 2022. Most of the bids were higher than the engineer's estimate for the 2023 rock. The rock was awarded for each township to the lowest bidder.

IX. Petition Requesting and Resolution Approving Appropriation of Funds from the County Bridge Fund, East Bend Township, Section #22-10125-00-BR

Mr. Blue discussed a culvert in East Bend Township that needs replaced. The cost to replace the culvert is estimated at \$39,950.00. East Bend Township is prepared to pay one-half the cost of replacement.

X. Resolution Appropriating \$6,000,000.00 from Champaign County Motor Fuel Tax Fund for the Improvement of County Highway 12 and County Highway 24, Section #22-00460-00-RS
 Mr. Blue requested approval of a Resolution appropriating \$6,000,000.00 of County Motor Fuel Tax Funds for a cold in place recycling project on County Highway 12 and County Highway 24. The projects will be bid together in 2023.
 MOTION by Ms. Taylor to approve the recolution: seconded by Mr. Sovten

MOTION by Ms. Taylor to approve the resolution; seconded by Mr. Sexton. Upon vote, the **MOTION CARRIED unanimously.**

 Mr. Blue discussed the resolution appropriating \$1,000,000.00 from County Motor Fuel Tax
 Funds for the rehabilitation of Structure #010-4271 on County Highway 6. The bridge is located about 1 mile north of the Monticello Road. Mr. Blue said the bridge has severely deteriorated steel and must be inspected every 3 months until it is replaced.
