Update on Construction Project

Cheryl reported that work has begun and barring any unforeseen circumstances, exhibit construction will be on schedule. They will produce 40,000 maps that will be supplied to incoming U of I students, the CVB and the courthouse and placed in Champaign-Urbana motels as well.
