b. Lincoln Heritage Area Grants - Looking for Lincoln Coalition

Wysocki said that Bird said the city thinks there are more sites to be recognized around the area of the Lincoln Elm. She said that Bird agrees that the LHA grants are not large enough.

c. Joan Dixon Follow - up

Grabow asked about the location of the items taken from the Wilbur Mansion. Cunningham said the items were in storage and were not inventoried. Grabow said it would be good if Pat Miller were with one of the historical groups. Voss said that would probably not happen. Wysocki said it would be worthwhile for her to contact Joan Dixon again to get a full sense of what Dixon has learned about the Cattle Bank and related groups.
