**Re:** Closed Session Minutes Review for Litigation Subcommittee

Dear Mr. Rosales:

Pursuant to the Illinois Open Meetings Act, a public body such as the Litigation Subcommittee is required to review its closed session minutes at least semi-annually. During this review, the Committee must determine whether the need for confidentiality still exists as to all or part of the closed minutes. If it is determined that the need for confidentiality no longer exists, the minutes must made available for public inspection.

Please note that the Committee may enter into closed session for the purpose of review of closed session minutes pursuant to 5 ILCS 120/2(c)(21): Discussion of minutes of meetings lawfully closed under the Act. Just as in open session, if the matter requires action by the Committee, the matter must have been noticed on the posted agenda. Although the body may discuss this semi-annual review in closed session, whichever conclusion the Committee draws must be reported in open session.

The County Board passed Resolution No. 7969, "Resolution Establishing Procedures for Semi-Annual Review of Closed Session Minutes by the Champaign County Board" on November 17<sup>th</sup>, 2011. Under the parameters established by the full board in Resolution 7969, none of the minutes are ripe for review to be opened.
