  - how to empower people about their employment rights: EEOC, HRC, sealing or expunging records
  - education in prison so that a person leaves prison with marketable skills, knowledge, possible degrees, certification, a resume, some money for work done
  - o detox/mental health emergency care in jail
  - how to prepare businesses to change attitudes about diversifying their workforce, have training on diversity and cultural differences
  - addressing stress of prejudice head on; providing mental health counseling from businesses and government (Urbana allows free weekly mental health counseling)
  - o parenting programs to help youth
