

Subject Property: A 31.835 acre tract plus a 5-acre lot that are proposed to be

subdivided into three lots located in the Northeast Quarter of the Northeast Quarter of Section 8, Township 17 North, Range 9 East of the Third Principal Meridian in Crittenden Township, with the

5-acre lot having an address of 493 CR 1400E, Tolono.
