SUPPLEMENTAL MEMORANDUM #4 October 14, 2021

Petitioner: Zoning Administrator

- **Request:** Amend the Champaign County Zoning Ordinance to establish beekeeping requirements as summarized in the full legal advertisement and summarized as follows:
 - 1. Amend Section 3.0 Definitions by adding a definition for "apiary", "beekeeping", "honey bee", "nucleus colony" and other related terms.
 - 2. Add footnotes 29 to Section 5.2 Table of Authorized Principal Uses.
 - 3. Add footnote 30 to Section 5.2 Table of Authorized Principal Uses.
 - 4. Add new Section 7.8 Beekeeping in the R-1, R-2, and R-3 Districts, with new requirements for beekeeping.
 - 5. Amend Section 9.3.1 G.6. by adding a \$33 Change of Use Permit Application Fee to establish beekeeping in the R-1, R-2, and R-3 Districts.



I am sending you my thoughts on the last board meeting and the packet of information sent out on Tuesday. The revised proposed amendment is definitely progress. In fact the community in question has only 1 hive currently. The proposal will allow 4 hives for any home. That exponentially increases the number of hives possible in the neighborhood, thus resolves nothing for these people and potentially exacerbates it. The older woman who said 'please help us' obviously did not understand this when Mr. Elwell tried to explain that in the last meeting. I think this amendment is a reaction to a resolved problem, I don't believe for a second that Rena will again have numerous hives on her property – there are many people who learn from their mistakes, which includes Rena. You have heard from multiple beekeepers, keeping beehives successfully living in multiple neighborhoods. This 3 foot fence with a latch on the inside? I do not understand. Is this to keep trespassers from getting stung? All beehives are to be registered with the Illinois Dept. of Agriculture. You are now wanting beehives also registered with the county - is that not redundant?

And a Zoning proposal for a permit along with registration with the state and registration with BeeWatch? Who has beekeeping experience on this board to review the zoning permits so approval is appropriately evaluated? You are proposing to be notified of every swarm caught and at an apiary and when it is moved?

I reiterate the State Dept. of Agriculture has bee inspectors who are experienced bee keepers who will and do respond to bee keepers with problems and any community problems.

I think the Best Bee Keeping Practice document labeled ATTACHMENT F is an excellent document, as is the Illinois Beekeeping Best Management Practices, and think any beekeeper would agree.

I believe this amendment does not solve a resolved problem for this neighborhood, potentially creates more problems, is redundant of the State Program, and is serious over kill.

It should be voted as denied since it redundant, over restrictive, and dictatorial to beekeepers from non beekeepers. Sincerely

Yes she has gotten it completely out of hand.. Losing usage of part of your property, like the pool or value to your property can make them liable financially for the loss. I would start documenting everything, dates, bees in the pool, the prescription of eppie pin, the cost and the life threatening risk associated with extreme reaction to be stings. While directly there are no laws governing bee hives outside the city you are entitled to the safe usage of your property and that is where the liability begins to accrue. Documenting the loss of enjoyment and significant risk to health impairment or even loss of life due to an extreme reaction to a bee sting is a cause for serious concern. These are all things that I was told by Legal Shield 1-312-782-2585. The cost for service is around \$20 a month. When NILAH died they put 5 lawyers on it to see me through it. A letter enumerating the risks of liability may encourage her and Drew to seek some reasonable conversation and answers.

Thank you Ken. I remember the issues you were having when you told me about them. Others in the neighbor hood have expressed the same concerns. I am very grateful for you contacting me with the Legal Shield information. I remember you telling me about that too. I can't find any Attorney's here in town that would even write a letter. Imaging that an Attorney turning down money. I have been to county zoning and the Environmental Land Use Committee of the county Board. They have been pretty apathetic in their response. There is no zoning in Urbana either. I was going to go the route of the 1 and 1/2 mile territorial jurisdiction of the city but they have nothing. My last resort is litigation. I have read once a bee keepers home owners insurance finds out there are issues their insurance goes up pretty high because of the liability. Thank you again and if you remember anything else please feel free to contact me. I'll keep you posted on progress if any.

Gentlefolks:

A review of the process resulting from Mr. Bryson's request for county wide regulations governing the placement of bee hives leads me to the following conclusions.

1. Mr Bryson has an available and considerably less restrictive solution to his complaint via modification of his subdivision home owner covenants.

2. Mr. Bryson's complaint is moot in that the honey bee colonies upon which his request for zoning restrictions was based have been removed from his neighborhood. The problem is highly unlikely to reoccur. As noted during an earlier hearing, the perusal of Mr. Bryson's request appears to be based on a solution in search of a problem.

3. Should any proposed regulations be approved, the monitoring and enforcement of these will result in continuous costs with very questionable benefits to the citizens of Champaign County.

4. As noted by others the proposals before the Zoning Board of Appeals are redundant with state requirements, overly restrictive, will discourage bee keeping and the pollination and other benefits derived, and impose an unnecessary expense on county tax payers.

5. Any proposed zoning regulations regarding bee keeping are unnecessary and should be denied.
