The well has a 6" steel well terminating above ground level. The well is equipped with a 3600 gallon pressure tank which keeps 1800 gallons of water on hand at all times. The well also has a 5 horsepower 50 gallon per minute submersible well pump to replenish water used. There is also 400' of 6" main waterline that holds on additional 600 gallons of water in reserve. High point daily usage is about 4400 gallons per day +/- and the well could easily supply 3 to 4 times that amount of water. With this begin said the pumping system will maintain more than enough water pressure and should never drop below 20 PSI. The well and pumping system are up to Illinois State Code and passes inspection.
