Part D - also as being good neighbors and residential nearby we should require a noise analysis performed for the data center

Zoning Committee:

I am writing you concerning the special petition of waivers for the solar farm proposed for Bondville. I am a property owner and volunteer firefighter for Bondville. I want it known I am against the proposed solar farm.

I know over the past several months, Donato Solar was expected to attend several meetings, either village board or zoning committee, to hear citizen comments and concerns but they did not attend. My guess is now they are circumventing the Village's processes to obtain permits by going through the county's zoning committee and requesting waivers. This leads me to believe the views of the citizens are not important to Donato Solar. By looking at the requested waivers, it appears Donato Solar's future intent is not to be a valued neighbor. In Part B, the request is for no weed control plan. This will be located on the most visible area of Bondville and on the surface sounds like a future eyesore and no landscaping plan. During initial talks with the Village, there were negotiations including a road that could lead to future commercial development. Part C requests to eliminate that. In Part D, it is requested to not submit a noise analysis. For the exisiting homes in the area, there is no concern for their tranquility. I saved Part A for last because I felt it was the most important. The request to have it within a half of a mile of the village will dramatically impact the growth of the village. Bondville's population sign has remained the same for at least 40 years. Champaign is running out of room to grow and villages like Bondville, could benefit from this. No devleoper nor home buyer is going to want to have a huge solar farm in their backyard. Bondville is surrounded by farmland that will remain so for generations, with the exception of this plot.

My other concerns with the solar farm are with the economic impact. My understanding is the power generated from the farm will not go back into the powergrid to benefit the community but will power Crypto-mining on the site. It appears to be an unmanned business, so it will not offer any employment opportunities for the community, either.

Please know I am not the only person concerned with the potential location of the Donato Solar farm. With the potential of growing to 77 acres, it will detrimentally impact the current residents and limit the potential of any future residents or commercial growth.
