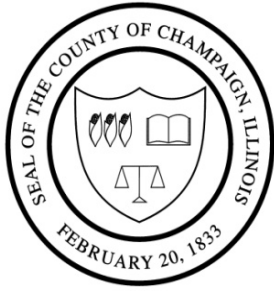

III. Nomination and vote for open AFSCME positions

V. Presentations by USI

A. Alternative Funding Analysis

USI representatives were present and provided a presentation breaking down the pros and cons of moving to a self-funded insurance plan and assured the committee that the employees would not notice any differences in how their insurance plan functioned. USI has noticed that since the closure of Health Alliance, the local entities have turned the conversation more toward self-funded plans and has made this topic move to the forefront of most renewal discussions across local municipalities. USI stated that they are seeing very high renewal rates already from Blue Cross Blue Shield this year and anticipate an increase in premiums if continuing to be fully funded. If the County was to move to a self-funded plan, it would be taking an additional risk but has the potential to save the County money overall.

Ms. Jett noted that last year other insurance carriers declined to bid on the County's renewal and asked if by moving to self-funded if the issue would persist. USI informed the committee that it would not and it would have more options with stop-loss carriers. Ms. Ogden asked if moving to self-funded would claims expenses be the same. USI informed the committee that the County would design the plan and could make it include or exclude certain services and coverages. Mr. McMahon noted that the committee should consider how axing certain coverages and services will affect employees and families.

B. 2025 Plan Performance Assessment

USI Representatives were present and provided a presentation for the committee providing an overview of how Champaign County compares to other entities, including those of a similar size, a similar industry, and within the same state. The benchmark report showed that Champaign County exceeds the standard for plan design and what employees pay out of pocket versus other entities, while there is room for improvement on the family plans.
