> Champaign County Local Emergency Planning Committee (LEPC) Meeting Minutes

I. Welcome and Introductions

Chairman John Dwyer called the meeting to order at 10:32 am and introductions were made.

II. Public Comment

No public comments were offered.

III. Review and approval of minutes from the November 28T^h, 2017 meeting

John Dwyer asked for motion to approve the minutes. Bill James made the motion to approve. Sherry Wooten seconded the motion and all approved.

IV. Follow-up on Commodity Flow Study-

Railroad surveyed was Canadian National Railroad (CN). Sharif Ullah stated the survey utilized pole mounted cameras and data was extracted from the rail car placarding. Data was reported by chemical class according to displayed placards. It was noted that placard car could be full of product or empty with vapors and residue which is equally dangerous. The percentage of hazardous classes identified are very close to the data from the road study. Flammable, Corrosives and gases are the most frequently transported material. The good cooperation of the railroads was recognized and is greatly appreciated.

V. LEPC Secretary position selection.

Stephanie Vogelsang volunteered to assume the position LEPC Secretary.

VI. Tier II reports – new health hazard information

Change to the information required to be submitted for Tier II requires for the submitter to identify from the menu options all known health and hazards associate with the chemical. Companies have submitted, per the State should go back and adjust their 2017 information.

VII. Local incidents, training, exercises and upcoming events discussion

Roll-over incident on I-57 in Ford County involving a package marker with radioactive labels. CFD HazMat responded. Training included the "Turn around, don't drown." Weather Spotting class was held on 29 March at Parkland, close to 150 people attended. CBRNE training with the Reserves. Fire Department training is being offered in Texas.

VIII. Open discussion and Wrap up

No additional comments were offered.
