June 30th, 2020

I. Welcome and Introduction

Chairman John Dwyer called the meeting to order at 10:31am and introductions were made.

II. Public Comment

There were no public comments

III. Review and approval of minutes from the February 25th, 2020

John Dwyer asked for a motion to approve the minute. Randy Fouts of MTD made the motion to approve. Anita Guffy seconded the motion and all approved.

IV. Local incidents, training, exercises and upcoming events discussion

1. 2019 Tier II data for the county complete

Tier II reporting began on January 1, 2020 and the last day of filing is March 1, 2020

Champaign county has 144 facilities in Tier 2. To date 63 facilities have reported EHS. There are laptops with data from 2019 CAMEO and MARPLOT that will be given to CFD. Brian Ball appreciates CCEMA sending the laptops.

CCEMA will be working with METCAD to give them the same data.

CCEMA will also be sending out google earth pro for 2019 data via email in next fire chiefs meeting?

2. Minor Incidents/spills since February

There were some diesel spills and a tank spill

3. High Hazard Flammable Train (HHFT) Information

The State provides CCEMA with an estimate of the number of trains meeting the High Hazard Flammable Train (HHFT) requirement and the frequency they pass through the county by week. Last updated about a month ago that there are about 2 trains per week. John will share this data with Champaign Fire.

4. IEMA Summit- September 8-11 (virtual)

The summit is possibly still happening, perhaps virtual. Iris confirmed that there has not been a decision made about whether the summit will take place.

V. Open Discussion and Wrap up

John Dwyer informed the LEPC that the International Association of Fire Chiefs is distributing a National (and possibly International) Survey that CCEMA may participate in.

Brian Ball, Champaign Fire Department HazMat asked the LEPC if anyone knows of a Certified Industrial Hygienist that will be contracted by CFD. John Dwyer may know someone who fits this description.

John Dwyer announces that there is a CoVid testing center in Market Place Mall that is free to use and people may be tested multiple times. John also encourages attendees to maintain social distancing and public health practices.

Robert Davies, CUPHD informs the group that the Department of Commerce has phase 4 guidelines on their website and encourages everyone who is unsure of the rules to check the website.
