<u>Summary</u>

The monthly IEMA and local emergency radio and siren tests were conducted. Our EMA volunteers also conducted their monthly radio test. The planning continued for the April 2013 full scale exercise with the National Guard in Rantoul and Urbana with the Master Scenario Events List Conference. EMA participated in the 2013 Great American Shakeout for earthquake preparedness. EMA took the Mobile Command Post to the monthly Fire Chief's Association meeting. The EMA liaison group met this month for upcoming events and for community awareness. EMA is still continuing to meet with Champaign Fire, Red Cross, and CUPHD about volunteer management. The Search and Rescue Core Group met to discuss upcoming training and monthly meetings for the Search and Rescue team to include land navigation classroom and field training, equipment and procedures. EMA will still be hosting the operations center for the Illinois Marathon in April. EMA hosted the monthly Public Information Officers (PIO) meeting to discuss upcoming events and media events. EMA hosted the quarterly Local Emergency Planning Committee Meeting on February 26th with local agencies and hazardous material facilities. EMA notified the National Weather Service on community events such as the Prairie North Exercise, Illinois Marathon, and Play It Safe for update weather information to ensure the safety of the event in regards to severe weather conditions.
