Summary

The monthly IEMA and local emergency radio tests were conducted. The **monthly siren test** was conducted. The agency hosted the EMA liaison meeting for the month of **May**. The **agency** posted articles and other information on social media outlets for severe weather **preparedness** and other activities. CCEMA attended the monthly Fire Chief's meeting where **EMA** discussed hazardous materials spill ordinances and information.
