Summary

The monthly IEMA and local emergency radio tests were conducted. The monthly siren test was conducted. The agency hosted the EMA liaison meeting for the month of August. The agency posted articles and other information on social media outlets for severe weather preparedness to include road closures, weather information, seasonal topics as well as other emergency management related information. EMA deployed the mobile command post for a barricade subject in support of METRO. We continue to get more followers on EMA twitter and friends on EMA Facebook accounts. CCEMA attended the monthly Fire Chief's meeting. The office continues to work the grant funded emergency accountability equipment and software for the accountability of personnel and resources specifically for disasters and events, over 700 IDs produced for various responder agencies. Search and Rescue team was put on standby for possible search, but deployment wasn't necessary. EMA hosted the Regional Emergency Coordination Group (RECG) Meetings on Aug 18th to discuss emergency management initiatives. The Local Emergency Planning Committee met to discuss the commodity flow study results and other hazardous materials related activities. EMA hosted the final planning meeting for the University of Illinois annual evacuation exercise.
