### **Summary**

The local and IEMA radio tests were conducted. The monthly siren test failed. CCEMA attended the monthly Fire Chief's Meeting. Search and rescue test alert was done. CCEMA provided regular twitter, Facebook, and website postings on weather info, emergency preparedness topics throughout the month.

- The monthly test of the OWSS failed due to cables being disconnected during building renovation. Problem was identified and corrected. Silent tests were conducted the same day and confirmed the system was back on-line and working as designed—June 5<sup>th</sup>.
- We continued to get more followers (1870 to date) on EMA twitter and friends on EMA Facebook accounts.
- Coordinated storm reports with locals and National Weather Service during severe weather—Jun 10<sup>th</sup> and 26<sup>th</sup>.
- Provided information to the local ESDA's and EMA twitter/Facebook feeds for excessive heat forecasts—Jun 4<sup>th</sup>, 26<sup>th</sup>, 28<sup>th</sup> and 29<sup>th</sup>.
- Provided information to the local ESDA's that conditions are favorable and reports received of funnel clouds being spotted in Central Illinois—Jun  $19^{th}$  and  $22^{nd}$ .
- Excessive heat advisory posting to twitter/Facebook—Jun 15th, 16th, 18th, 19th, 26th, 28th and 29th.
- Assisted NWS in determining the path and extent of damage from the Jun 26th tornado—Jun 27th.

- Attended USPS Biohazard Detection System (BDS) meeting at the post office on Mattis—Jun 5<sup>th</sup>
- Attended the Lidar presentation from GIS—Jun 26<sup>th</sup>
- Attended County Hazard Mitigation Annual Plan Review—Jun 28th
