Subject:	June Board Report

Summary

Champaign County Emergency Management Agency (CCEMA) remains focused on the COVID-19 response and recovery with an emphasis on vaccine administration. This effort includes public messaging, oversite of the testing site at Marketplace Mall, and supporting the vaccination clinics. This period included a focus on messaging the importance of vaccines to all residents in Champaign County.

COVID-19 Response

John Dwyer continues to serve as the Emergency Operations Center (EOC) Manager to support response efforts for Champaign County during the Pandemic. Collin Rector, the Deputy EMA Coordinator, is serving as the Logistics Chief in the EOC. **Champaign County has distributed 183,813 pieces of PPE** including N95 respirators, surgical masks, hand sanitizer, gloves, touchless thermometers, and other support items. CCEMA also maintains supervision of the Champaign County Testing Center near Marketplace Mall. **The center tested 147,461 people** as of May 31st, 2021, since officially opening on May 19, 2020. The County EOC also established a PPE reserve that is stored at CUPHD in case of emergency. This is a 90-day stock to support first responders and the hospitals in case of resurgence.

Other Notable Events


- 69 volunteer total hours were completed in service of Champaign County EMA in June

- John Dwyer did a presentation at the Champaign County Farm Bureau's Women's Committee Meeting
- CCEMA monitored several potential severe weather events-June 9, 18,20, 24-26th
- Submitted multiple community events to the NWS for weather support/safety
- Attended Decon Trailer demonstration at Corteva Production Facility in St. Joseph
- Distributed bulk hand sanitizer to Fisher Fair & Tolono Fun Day
