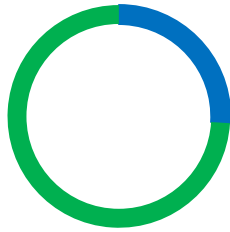
Notable Events

- Hosted the East Central IL Community Organizations Active in Disasters (COAD) Meeting at ILEAS – Aug 31st

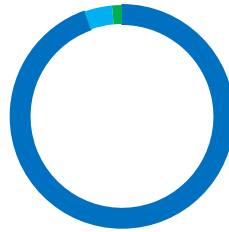

CCEMA had **24,997 views** of its social media content and gained an additional **312 new followers**.

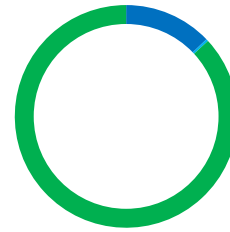
Post Views
