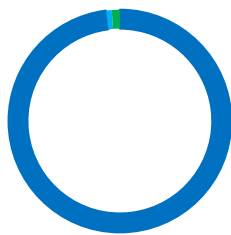
Notable Events

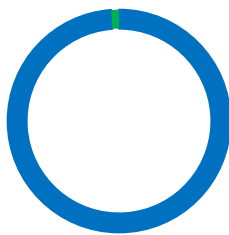
Information Dissemination to Champaign County

CCEMA had **109,908 views** of its social media content and gained an additional **375 new followers**.

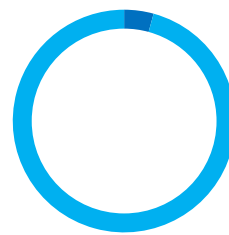
