- Provided a radio cache to support Illinois Football Game Operations—Oct 31st

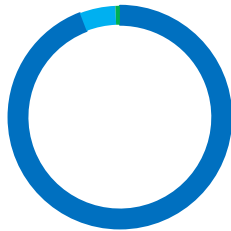

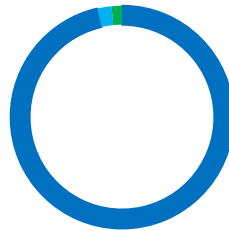
Information Dissemination to Champaign County

CCEMA had **62,002 views** of its social media content and gained an additional **143 new followers**.

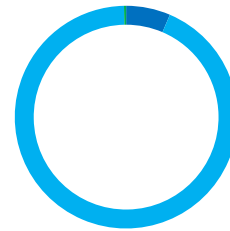
