FIRST AMENDMENT TO THE LEASE AGREEMENT

NOW, THEREFORE, in consideration of the demise, rents, covenants and agreements by the Village and the Lessee as parties to the Lease, including those as contained in this First Amendment to the Lease, the Village and the Lessee do hereby mutually covenant and agree to supplement and extend the Lease to provide as follows:

"Commencement Date" means March 1, 2023.

"Term" means from March 1, 2023 to February 29, 2024

"Rent" is hereby set to \$6,720.00 annually as of the first extension commencement date.

"Monthly Rent Installment" is hereby set to \$560.00 per month as of the first extension commencement date.

EXCEPT AS EXPRESSLY STATED, all other provisions of the Lease, including as supplemented and amended by this First Amendment, are hereby ratified, confirmed and approved by both the Village and the Lessee.
