### CONTRACTOR CERTIFICATIONS

The certifications hereinafter made by the bidder are each a material representation of fact upon which reliance is placed should the Department enter into the contract with the bidder.

- 1. **Debt Delinquency.** The bidder or contractor or subcontractor, respectively, certifies that it is not delinquent in the payment of any tax administered by the Department of Revenue unless the individual or other entity is contesting, in accordance with the procedure established by the appropriate Revenue Act, its liability for the tax or the amount of the tax. Making a false statement voids the contract and allows the Department to recover all amounts paid to the individual or entity under the contract in a civil action.
- Bid-Rigging or Bid Rotating. The bidder or contractor or subcontractor, respectively, certifies that it is not barred from contracting with the Department by reason of a violation of either 720 ILCS 5/33E-3 or 720 ILCS 5/33E-4.

No corporation shall be barred from contracting with any unit of State or local government as a result of a conviction under this Section of any employee or agent of such corporation if the employee so convicted is no longer employed by the corporation: (1) it has been finally adjudicated not guilty or (2) if it demonstrates to the governmental entity with which it seeks to contract that entity finds that the commission of the offense was neither authorized, requested, commanded, nor performed by a director, officer or a high managerial agent on behalf of the corporation.



# DESCRIPTION OF WORK

This work shall consist of the construction of a revised at-grade railroad crossing with the existing ICGR on TR 307 (100N). This crossing has received automatic flashing light signals and gates as part of the Grade Crossing Protection Fund. This installation was constructed by others. The new grade crossing approaches shall adhere to Section 1535.204, Grade Line of Highway Approaches, of Part 1535, Crossings of Rail Carriers and Highways. Unless otherwise specified, the proposed grade line shall be reconstructed as specified in that Section. The work shall include the placement of an aggregate base course that will be seal coated once the aggregate is graded and compacted to the required specifications.

Not more than 16 percent or less than 4 percent of the materials shall pass a No. 200 sieve determined in accordance with AASHTO T-11; and the plasticity index of the material passing a No. 40 sieve determined in accordance with AASHTO T 90 shall not exceed 6, unless the use of other materials is authorized in writing by the Engineer. The material shall not contain aggregate particles larger than 3 inches, nor an excessive amount

of soft or friable particles with mineral aggregates, as determined in accordance with AASHTO T-112, which may readily break down into fine material. The combined content of such soft particles with mineral aggregate plus the content of material passing the No. 200 sieve by the wet sieving process shall not exceed 20 percent of the total sample.

If materials meeting the foregoing requirements cannot be obtained from excavations of existing granular subbase aggregate within the project limits or from borrow areas developed by the Contractor, the material shall be obtained from other sources selected by the Contractor and approved by the Engineer, at no additional cost.

The use of air-cooled blast furnace slag or steel slag will not be allowed. No reinforcement, subgrade soils, or organic material shall be present.

### General Requirements:

Any existing subbase aggregate that is to be reused as Subgrade Granular Embankment, Special shall be excavated and stockpiled in accordance with this Special Provision or windrowed after which the subgrade shall be prepared in accordance with Section 301 of the Standard Specifications. Prior to final approval for placing of the Subgrade Granular Embankment, Special, the subgrade shall be prepared and checked for specified density in accordance with Article 301.04 of the Standard Specifications. Placing of loose material on the finished subgrade shall not proceed until the subgrade has been approved by the Engineer for a distance of not less than 500 feet in advance of the laying of the granular embankment, special material. No material shall be placed upon overly moist, muddy or otherwise unstable subgrade or on material containing frost at any depth. Should the subgrade be dry to the point of being dusty, it shall be moistened by sprinkling as may be directed by the Engineer.

After the granular embankment, special material has been spread uniformly on the prepared subgrade, any portion of the layer in which segregation has occurred shall be removed and replaced with satisfactory material, or shall be remixed as directed by the Engineer.

If the material is too dry, it shall be uniformly moistened by sprinkling and by manipulating the material in a manner approved by the Engineer, such that the moisture will be evenly distributed throughout the depth of the material. If the material is too moist, it shall be allowed to dry and, if necessary to achieve uniform distribution of moisture throughout its depth, it shall be manipulated in a manner approved by the Engineer. During preparation, construction, and after completion of the Subgrade Granular Embankment, Special, adequate drainage shall be provided at all times to prevent water from standing on the granular embankment, special surface. The granular embankment, special shall be so constructed that it will have, as nearly as possible, uniform density throughout.

The finished surface of the granular embankment, special shall not vary more than one-tenth (0.1) foot

below the elevation shown on the Plans. No tolerance above the Plan elevations will be allowed. Any deviation in excess of this amount shall be corrected by loosening, adding or removing materials, reshaping and re-compacting or sprinkling and rolling, all at the Contractor's expense.

No hauling shall be done nor equipment moved over the granular embankment, special when its condition is such that undue distortion will result. If these conditions prevail, the granular embankment, special shall be protected with adequate plank runways, mats, or other satisfactory means, if hauling is done thereon.

Compaction:

The granular embankment, special shall be compacted to 95 percent of the maximum dry density as

determined by AASHTO T 99, Method C. The granular embankment, special thus compacted shall cover the full width of the section as shown on the Plans. Additional water shall be added when needed during compaction operations to obtain the specified density and optimum moisture content.

Compaction of the granular embankment, special shall be obtained using equipment conforming to the requirements of Section 1101 or by other equipment approved by the Engineer.

Compacting shall start at the edges and progress towards the center, and shall continue until the required density as herein specified is obtained. When the proper cross-section has been obtained and compaction is completed, the surface shall be rolled with a flatwheel roller to seal the surface.

Method of Measurement:

Aggregate used for SUBGRADE GRANULAR EMBANKMENT, SPECIAL will be measured for payment in Tons.

Water required to be added for compaction of the grade will not be measured for payment, but shall be considered as included in the cost of the item of work being constructed.

Basis of Payment:

Payment for SUBGRADE GRANULAR EMBANKMENT, SPECIAL, measured as specified, will be made at the Contract unit price per ton, which payment shall constitute full compensation for furnishing, transporting, and placing the material as specified.

#### RAILROAD FLAGGERS

Contractors who perform any work on railroad-owned property are required to have a Railroad Flagger available before and during all operations that are within 50-feet of the railroad tracks or facilities.

Basis of Payment:

All work requiring the use of a railroad flagger will be paid as force account work based on guidelines included in Sec. 109.04 of the Standard Specifications for Road and Bridge Construction.



A separate policy is required for each railroad indicated on the attached form unless otherwise noted. The limits of liability for each policy are listed on the attached form. The minimum limits of liability shall be in accordance with Article 107.11 of the Standard Specifications.

**Basis of Payment**. The costs for providing insurance, as noted above, will be paid for at the contract unit price per Lump Sum for RAILROAD PROTECTIVE LIABILITY INSURANCE.

APPROVAL OF INSURANCE: The ORIGINAL and one CERTIFIED copy of each required policy shall be submitted for approval to the following address:

The contractor will be advised when approval of the insurance has been received from the railroad(s). #### **Explanations CHAMPAIGN COUNTY**

The following list is considered as those days for which holiday rates of wages for work performed apply: New Years Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Day and Veterans Day in some classifications/counties. Generally, any of these holidays which fall on a Sunday is celebrated on the following Monday. This then makes work performed on that Monday payable at the appropriate overtime rate for holiday pay. Common practice in a given local may alter certain days of celebration. If in doubt, please check with IDOL.

Oil and chip resealing (O&C) means the application of road oils and liquid asphalt to coat an existing road surface, followed by application of aggregate chips or gravel to coated surface, and subsequent rolling of material to seal the surface.

#### EXPLANATION OF CLASSES

ASBESTOS - GENERAL - removal of asbestos material/mold and hazardous materials from any place in a building, including mechanical systems where those mechanical systems are to be removed. This includes the removal of asbestos materials/mold and hazardous materials from ductwork or pipes in a building when the building is to be demolished at the time or at some close future date.

ASBESTOS - MECHANICAL - removal of asbestos material from mechanical systems, such as pipes, ducts, and boilers, where the mechanical systems are to remain.

## CERAMIC TILE FINISHER, MARBLE FINISHER, TERRAZZO FINISHER

Assisting, helping or supporting the tile, marble and terrazzo mechanic by performing their historic and traditional work assignments required to complete the proper installation of the work covered by said crafts. The term "Ceramic" is used for naming the classification only and is in no way a limitation of the product handled. Ceramic takes into consideration most hard tiles.

#### ELECTRONIC SYSTEMS TECHNICIAN

Installation, service and maintenance of low-voltage systems which utilizes the transmission and/or transference of voice, sound, vision, or digital for commercial, education, security and entertainment purposes for the following: TV monitoring and surveillance, background/foreground music, intercom and telephone interconnect, field programming, inventory control systems, microwave transmission, multi-media, multiplex, radio page, school, intercom and sound burglar alarms and low voltage master clock systems.

Excluded from this classification are energy management systems, life safety systems, supervisory controls and data acquisition systems not intrinsic with the above listed systems, fire alarm systems, nurse call systems and raceways exceeding fifteen feet in length.

TRUCK DRIVER - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION Class 1. Drivers on 2 axle trucks hauling less than 9 ton. Air compressor and welding machines and brooms, including those pulled by separate units, truck driver helpers, warehouse employees, mechanic helpers, greasers and tiremen, pickup trucks when hauling materials, tools, or workers to and from and on-the-job site, and fork lifts up to 6,000 lb. capacity.

Class 2. Two or three axle trucks hauling more than 9 ton but hauling less than 16 ton. A-frame winch trucks, hydrolift trucks, vactor trucks or similar equipment when used for transportation purposes. Fork lifts over 6,000 lb. capacity, winch trucks, four

axle combination units, and ticket writers.

Class 3. Two, three or four axle trucks hauling 16 ton or more. Drivers on water pulls, articulated dump trucks, mechanics and working forepersons, and dispatchers. Five axle or more combination units.

Class 4. Low Boy and Oil Distributors.

Class 5. Drivers who require special protective clothing while employed on hazardous waste work.

#### TRUCK DRIVER - OIL AND CHIP RESEALING ONLY.

This shall encompass laborers, workers and mechanics who drive contractor or subcontractor owned, leased, or hired pickup, dump, service, or oil distributor trucks. The work includes transporting materials and equipment (including but not limited to, oils, aggregate supplies, parts, machinery and tools) to or from the job site; distributing oil or liquid asphalt and aggregate; stock piling material when in connection with the actual oil and chip contract. The Truck Driver (Oil & Chip Resealing) wage classification does not include supplier delivered materials.

OPERATING ENGINEERS - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION Class 1. Draglines, Derricks, Shovels, Gradalls, Mechanics, Tractor Highlift, Tournadozer, Concrete Mixers with Skip, Tournamixer, Two Drum Machine, One Drum Hoist with Tower or Boom, Cableways, Tower Machines, Motor Patrol, Boom Tractor, Boom or Winch Truck, Winch or Hydraulic Boom Truck, Tournapull, Tractor Operating Scoops, Bulldozer, Push Tractor, Asphalt Planer, Finishing Machine on Asphalt, Large Rollers on Earth, Rollers on Asphalt Mix, Ross Carrier or similar Machine, Gravel Processing Machine, Asphalt Plant Engineer, Paver Operator, Dredging Equipment, or Dredge Engineer, or Dredge Operator, Central Mix Plant Engineer, CMI or similar type machine, Concrete Pump, Truck or Skid Mounted, Engineer or Rock Crusher Plant, Concrete Plant Engineer, Ditching Machine with dual attachment, Tractor Mounted Loaders, Hydro Crane, Standard or Dinkey Locomotives, Scoopmobiles, Euclid Loader, Soil Cement Machine, Back Filler, Elevating Machine, Power Blade, Drilling Machine, including Well Testing, Caissons, Shaft or any similar type drilling machines, Motor Driven Paint Machine, Pipe Cleaning Machine, Pipe Wrapping Machine, Pipe Bending Machine, Apsco Paver, Boring Machine, (Head Equipment Greaser), Barber-Greene Loaders, Formless Paver, (Well Point System), Concrete Spreader, Hydra Ax, Span Saw, Marine Scoops, Brush Mulcher, Brush Burner, Mesh Placer, Tree Mover, Helicopter Crew (3), Piledriver-Skid or Crawler, Stump Remover, Root Rake, Tug Boat Operator, Refrigerating Machine, Freezing Operator, Chair Cart- Self-Propelled, Hydra Seeder, Straw Blower, Power Sub Grader, Bull Float, Finishing Machine, Self-Propelled Pavement Breaker, Lull (or similar type Machine), Two Air Compressors, Compressors hooked in Manifold, Chip Spreader, Mud Cat, Sull-Air, Fork Lifts (except when used for landscaping work), Soil Stabilizer (Seaman Tiller, Bo Mag, Rago Gator, and similar types of equipment), Tube Float, Spray Machine, Curing Machine, Concrete or Asphalt Milling Machine, Snooper Truck-Operator, Backhoe, Farm Tractors (with attachments), 4 Point Lift System (Power Lift or similar type), Skid-Steer (Bob Cat or similar type), Wrecking Shears, Water Blaster.

Class 2. Concrete Mixers without Skips, Rock Crusher, Ditching Machine under 6', Curbing Machine, One Drum Machines without Tower or Boom, Air Tugger, Self-Propelled Concrete Saw, Machine Mounted Post Hole Digger, two to four Generators, Water Pumps or Welding Machines, within 400 feet, Air Compressor 600 cu. ft. and under, Rollers on Aggregate and Seal Coat Surfaces, Fork Lift (when used for landscaping work), Concrete and Blacktop Curb Machine, One Water Pump, Oilers, Air Valves or Steam Valves, One Welding Machine, Truck Jack, Mud Jack, Gunnite Machine, House Elevators when used for hoisting material, Engine Tenders, Fireman, Wagon Drill, Flex Plane, Conveyor, Siphons and Pulsometer, Switchman, Fireman on Paint Pots, Fireman on Asphalt Plants, Distributor Operator on Trucks, Tampers, Self-Propelled Power Broom, Striping Machine (motor driven), Form Tamper, Bulk Cement Plant, Equipment Greaser, Deck Hands, Truck Crane Oiler-Driver, Cement Blimps, Form Grader, Temporary Heat, Throttle Valve, Super Sucker (and similar type of equipment).

Class 3. Power Cranes, Truck or Crawler Crane, Rough Terrain Crane (Cherry Picker), Tower Crane, Overhead Crane.

Other Classifications of Work:

For definitions of classifications not otherwise set out, the Department generally has on file such definitions which are available. If

a task to be performed is not subject to one of the classifications of pay set out, the Department will upon being contacted state which neighboring county has such a classification and provide such rate, such rate being deemed to exist by reference in this document. If no neighboring county rate applies to the task, the Department shall undertake a special determination, such special determination being then deemed to have existed under this determination. If a project requires these, or any classification not listed, please contact IDOL at 217-782-1710 for wage rates or clarifications.

#### LANDSCAPING

Landscaping work falls under the existing classifications for laborer, operating engineer and truck driver. The work performed by landscape plantsman and landscape laborer is covered by the existing classification of laborer. The work performed by landscape operators (regardless of equipment used or its size) is covered by the classifications of operating engineer. The work performed by landscape truck drivers (regardless of size of truck driven) is covered by the classifications of truck driver.
