

## **AMENDMENT TO INMATE FOOD AND COMMISSARY SERVICES AGREEMENT**

This Amendment to the Food Service Agreement is made effective October 4, 2024 ("Effective Date"), by and between the County of Champaign, Illinois and the Champaign County Sheriff's Office (hereinafter referred to as "County ") and Trinity Services Group, Inc., and its commissary services subcontractor Keefe Commissary Network, LLC (hereinafter referred to as "Contractor").

WHEREAS, Contractor and County entered into an Inmate Food Services and Commissary Services Agreement dated May 1, 2023, whereby Trinity provides a food and commissary services for the County ("Agreement"), and

WHEREAS, the parties desire to amend the Agreement as follows.

NOW, THEREFORE, in consideration of the forgoing facts, the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree that the Agreement shall be amended as follows:

1. As of May 1, 2024, Attachment A in the Agreement will be deleted in its entirety and replaced with the Attachment A herein.
2. Section 4 will be amended to have the following sentence added at the end:

“Effective as of September 1, 2024, the parties agree that no commissions provided by this paragraph will be paid to the County until the inmate population returns. This return is anticipated to be November or December of 2024. Such commissions will resume as of January 1, 2025.”

3. Effective January 1, 2025, the first sentence of Section 6 is hereby deleted in its entirety and replaced with the following:

“Subcontractor shall pay a commission to the Inmate Trust (Commissary) Fund in the amount of Thirty Percent (30%) of Net Sales (defined as total sales, less sales or use taxes and authorized returns) of all Products, except indigent kits, postage stamps, pre-stamped envelopes, or any other item sold at cost, all of which have no commission.

4. Except as expressly stated herein, all of the terms and conditions of the Agreement, as previously amended, shall remain in full force and effect.


